
ABOUT US





Executive Summary

Darul Quranul Karim (DQK) continued its charitable activities in 2025, focusing on peacebuilding, education, healthcare, welfare, and poverty alleviation. The organization was fully funded through Sadaqah contributions from members and well-wishers. During the year, DQK received KES 483,352 in donations and incurred KES 483,223 in expenses.

Organization Background

Darul Quranul Karim is a charitable organization established to support community development and social welfare initiatives. The organization operates on a non-profit basis and relies entirely on donations to finance its activities. The organization's key areas of focus include:

- Providing faith-inspired and values-based education and moral development
- Supporting vulnerable children, orphans, and needy families
- Coordinating community development and peacebuilding programs
- Offering welfare support to volunteers and local beneficiaries
- Maintaining a physical center to support program implementation

DQK operates on a non-profit basis and relies entirely on donations.

Directors' Report

The Directors present the Annual Report and Financial Statements of Darul Quranul Karim for the year ended 31 December 2025. During the year under review, the organization continued to pursue its values-based and charitable objectives in accordance with its mandate. The land acquired in 2017 and the mosque constructed in 2021 continued to support the delivery of programs and activities. These assets are recognized as property, plant, and equipment in accordance with IAS 16 – Property, Plant and Equipment. The Directors confirm that the organization remains a going concern and has adequate resources to continue its operations for the foreseeable future.

Note for the Financial Statement

1. Basis of the preparation

The financial statements have been prepared in accordance with International Financial Reporting Standards (IFRS)

2. Property, Land and Equipment

Land is stated at cost and is not depreciated. Buildings are depreciated on a straight-line basis over their estimated useful lives. The mosque constructed in 2021 is depreciated over 40 years. Depreciation charged for the year amounted to KES 28,862.

3. Prior Period Adjustment

In prior years, depreciation relating to the mosque building was not recognized. During the year, management corrected this by recognizing accumulated depreciation of KES 115,448 against accumulated funds, in accordance with IAS 8 – Accounting Policies, Changes in Accounting



Darul Quranul Karim-Donor Summary 2025


